

Services include case management, financial counseling, children services advocacy and linkages with our Adopt-a-Family transitional housing program with community resources. Referrals come from the Arlington County Department of Human Services Crisis Assistance Bureau. The average length of stay is approximately five to six months.

Adopt-a-Family Arlington is a transitional housing program from the homeless families in private rental housing in Arlington, Virginia.
